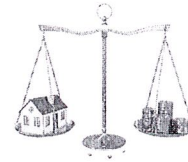

The assessor is a local government official who estimates the fair market value of property within a city, town, or village's boundaries. This value is converted into an assessment, which is one component in the computation of property tax bills. There are 25 towns and 3 cities in Erie County alone and each one needs an Assessor. Being an Assessor encompasses computer programs, public relations and marketing, leadership, math, interaction with the public, research, involvement in the legal world, working with town government, preparing budgets, reading blueprints and maps, both written and verbal communications and the list goes on. There is ALWAYS something new! A career as an Assessor requires a New York State Certification, which is presented at the completion of the required courses.

We believe that working as a public servant can be very rewarding and interesting and there are so many different avenues. Helping those in your community receive fair treatment is a worthy profession.
